Pond

- · Addition of fish is under review
- Pond treatment getting permits, getting bids
- Investigating for aeration to promote survival of fish and the health of the pond

Building Committee

- The committee reviews for restriction violations
- Members need to review and follow local requirements

Restrictions (sub 2)

- Approach used previous efforts and communicated desires, comparing current to proposed, clarify language and update requirements, held meetings with sub 2 members
- Open meeting for Sub 2 proposal
- Review with lawyer
- Update if required updates cleared by lawyer
- Voting process Vote by section (fences, driveways, sheds,)
- Establish vote date and complete vote
- If sections pass (requires 2/3 of Sub 2) register new restrictions
- If rejected solicit feed back for revisions / leave as currently stated
- No voting on legal items required in content.

Roads

- Livingston County Road Commission stated in 2014 that there are no plans for repaving the roads.
- We have had several estimates ranging from \$800K to \$1,000K
- · No houses with driveway on Ten Mile included
- We need to pass a vote of > 50% that agree to proceed with roads
- Survey indicated less than 50% support road repair (39 No, 22 Yes)
- Currently not enough support to continue
- The cost of the roads would be added to your taxes.
- Investigation of other options
- We encourage membership to contact the Road Commission directly on pot holes.

Ballot Results

- The proposed dues for 2017 of \$150 passed with 53 Yes votes and 8 No votes
- The proposed monument fund = passed with 48 Yes votes and 11 No Votes
- The following members were elected to the board for a term of 2 years from April 2017 to April 20199.
