Pond

Due to the weather this year, the pond will need three treatments this year which falls within the budget. A fourth treatment may be needed this year due to the weather and the pond will be monitored.

A pump option for aeration is being researched to keep the pond weeds from growing and to reduce the number and mount of chemical treatments.

Reports of plenty of fish in the pond, people are fishing and doing catch and release.

Invasive plants on the edge of the pond can be treated in the pond and we will get a quote for that treatment next year.

Lawn

Lighting has been a doing a great job

Many trees are either down, standing dead and there are brush piles to clean up. A quote for this work will be gotten and the work will be done within the budgeted amount for FY17.

There was an open meeting of the membership on April 17, 2017, sorry that you were not able to attend

The initial amount set aside in the budget was to start the funding process by setting monies aside to hold in reserve while a face lift of the monuments is evaluated. Unlike other budget items for spending this one was to establish a fund to reserve the money for the project. Since the total needed is not known until design is finalized this puts a hold on the money. The setting aside of funds shows membership support and approval for the concept but not spending until plans and a total cost is approved by a vote of the membership.

The committee will develop several options to present to the membership. They will collect additional input and present the design and cost for a membership vote. We know this process takes time for collecting ideas and voting. We also want to ensure members are available so we are planning to have drafts ready an open meeting to be scheduled this Fall.

Thank you for the response. Interesting how the board neglected to explain the "possible" updating of the entrances when presenting the budget. This explanation you just sent me is very misleading and concerning. Though I'm not surprised that the board did not have a firm plan prior to starting this project without the financial backing of the members of Oakwood Meadows homeowners. The board asked for \$3000.00 for updating. Nothing more. How much do you anticipate this will cost. What are the preliminary plans? How are you going to ask the members for their ideas, desires, approval and when?

How did you choose who would be on the committee? Did you ask anyone other than the board or your friends? Curious that we never heard about a committee. No open meetings might be the reason. Which is another concern of many.

There are several homes in the subdivision that need major work done on their yards. I am not going to police this sub. That is the responsibility of the board. These homes are very obvious if someone takes a few minutes of their time to either walk or drive around. It doesn't cost money to pull weeds, mow or move trash out of sight. That can not be the excuse given. The township has an ordinance to address this if the board doesn't want to take it on. I believe there is a fine that the township can impose on a homeowner if they don't comply. You might want to mention that when you contact them.

These are just a few that stick out. These homes are in violation of our restrictions - weeds growing to over a foot high. Trash, wood stacks, dog houses, wire fences and other things of this nature continue to be a detriment to our subdivision. The roads are bad enough but if residents would keep their properties neater, it would benefit all.

A committee has been formed to review the possibilities for updating the front monuments. Once drafts are completed and quoted these will be shared with the membership for selection.
