- Current bank account balances as of April 1st, 2016

- Total amount of checks written for 2015 \$8,491.22
- Waiting on an invoice for 2015 pond treatment of around \$2,000

Board and committee reports:

President Comments

- The OakwoodMeadows.org web site is updated at a minimum of every 2 months
- All inquiries to the board of potential violations were all closed
- Amended Restrictions for sub 1 passed
- Fish added to the pond, 350 bluegills, 30 catfish, 70 bass, 8000 minnows
- Pond was treated
- Added flowering tree to the front entrance
- Repaired the front entrance lights
- A survey of sub 2 received 45 responses out of 64 members
- A sub 2 restriction draft review meeting was held April 12th 2016
- Sub 2 restrictions will continue to be reviewed with the sub 2 membership for refinement
- 99 members have paid their 2015 dues Thank you to the membership
- Continue to investigate the best path for road repair
- We look forward to continuing progress for our association
- Discussion on how violations were resolved

Pond

- Addition of fish in the Spring of 2015
- Celebration at the pond to put in the fish
- Pond treatment
- Removal of No Parking signs in front of the pond to improve utilization

Front Entrance

- Lettering needs to be fixed on the signs
- Discussion on adding a "restricted community" sign
- Chips are needed

Building Committee

- Please be sure to contact the committee before you start
- The committee reviews for restriction violations
- Members need to review and follow local requirements

Restrictions

- Approach use the previous efforts and communicated desires, comparing the current to proposed, clarify language and update requirements
- Reviewing draft by sub 2 members
 - First review April 12th
 - Second review in May
- Revise the draft based on membership input
- Review with lawyer
- Open meeting for sub 2 to review the proposal
- Update if needed
- Define the voting process entire document or by sections
- Establish a vote date
- If pass (requires 2/3 of sub 2) to register new restrictions
- If rejected, then solicit feedback for revisions

Roads

- The Association does not own the roads or drains
- Livingston County Road Commission stated in 2014 that there are no plans for repaving the roads
- Several estimates ranging from \$800k to \$1,000k
- We need to pass with a vote of >50% to proceed with road discussions with the County
- No houses with a driveway on Ten mile are included
- If passed, the country will refine repair estimates and plan next steps
- Members need to decide if we want the Board to pursue road resurfacing activities which are currently not in the scope of the Board responsibilities. Response from the attendees was a Yes
- The cost of the roads would be added to your taxes
- We are on the scheduling for road sweeping
- We encourage members to contact the Road Commission directly on pot holes

Ballot Results

- The proposed dues for 2016 of \$135 passed with 52 Yes votes and 2 No votes
- The following members were elected to the board for a term of 2 years from April 2016 to April 2018.
